2024 Expression of Interest (EOI) Guidelines for Clinical Masterclass May 2024, Westmead Innovation Centre, 10th and 17th May

1. SHP Masterclass Program Overview

About Sydney Health Partners

Sydney Health Partners (SHP) is a NHMRC accredited Research Translation Centre (RTC) alongside 11 other RTCs across Australia. Please refer to our <u>website</u> for further information.

Sydney Health Partners' goals include building capacity and capability in the workforce and demonstrating that evidence-based interventions can be successfully implemented and scaled-up in large and diverse health systems. Our partners comprise five large health services (Nepean Blue Mountains Local Health District, Northern Sydney Local Health District, Sydney Children's Hospitals Network (at Westmead), Sydney Local Health District and Western Sydney Local Health District), the University of Sydney and 11 medical research institutes.

The SHP Implementation Science Academy was launched in March 2023 and contributes to SHP's vision to 'transform the way research improves patient care and public health in our health system' by accelerating the transfer of research innovations into health care improvements. About Implementation Science

Implementation Science is "the scientific study of methods to promote the systematic uptake of research findings and other evidence-based practices into routine practice, and, hence, to improve the quality and effectiveness of health services" ¹. It seeks to understand the behaviour of healthcare professionals and other stakeholders as a key variable in the sustainable uptake, adoption, and implementation of evidence-based interventions. About the Masterclass

In 2024 two (2) separate Masterclass Programs will be held, each has a different eligibility criteria but both have the same selection criteria, these guidelines relate to the Clinical Masterclass to be held in May 2024.

SHP has designed the Masterclass as a practical introduction to the science of implementation for health professionals and health researchers. The aim is to build capacity and expertise across SHP, thereby better enabling health professionals and researchers within the healthcare system to:

- Solve complex problems
- Translate evidence into practice

- Tackle clinical problems that need practical solutions
- Impact on patient outcomes in the longer term


The 2024 Masterclass program consist of:

- *Clinical Masterclass:* for clinical projects delivered in a clinical setting aimed at clinical staff, members of SPH's Clinical Academic Groups, and employees of Sydney Heather Partner Organisations to develop their skills within the field of Implementation Science (May 2024).
- Academic Implementation Science Network (AISN) Masterclass: aimed at supporting members
 of the Faculty of Medicine and Health (FMH) AISN to enhance translational research and
 specifically implementation science expertise across the University of Sydney and Sydney
 Health Partners partner organisations. Attendees of the AISN Masterclass are required to hold
 a position, affiliation or be a higher degree research student within the University of Sydney
 (September 2024).

The research pipeline is illustrated in Figure 1 below. The Masterclass intends to support colleagues working on implementation studies, **rather than** preintervention, efficacy or effectiveness studies.

Note: If your project includes design for implementation as part of an efficacy or effectiveness study, you will still be eligible for the Masterclass. Projects that are exploring the suitability and readiness for implementation, preparing for implementation, or are ready to evaluate implementing or sustaining an evidence-based intervention into practice will be favoured.

*These dissemination and implementation stages include systematic monitoring, evaluation, and adaptation as required.



2. Eligibility

Member of a SHP	Clinical Masterclass

Employment	Clinical Masterclass			
	Participants must be employees at a SHP partner organisation.			
	AISN Masterclass			
	Attendees are required to be primarily employed through the University of Sydney. Affiliates and Higher Degree Research students of the University of Sydney will also be considered.			
Member of the	Clinical and AISN Masterclass			
СоР	Applicants must have signed-up to become a member of the SHP Implementation Science Academy Community of Practice (CoP). If you are not yet a member, you can sign-up <u>here</u> . We want to ensure that all participants in the Masterclass are engaged with our CoP and can share useful insights and learnings from the Masterclass with other members of the CoP.			
	Failure to join the CoP may make your application ineligible.

Applications that do not include a SHP partner organisation will be considered ineligible. 3. Selection Criteria

	organisational or health service change, including pilot testing of			
	interventions or implementation strategies. The concept does not need to			
	be a polished piece of work as each applicant will develop the concept			
	throughout the Masterclass.

4. Conditions of Masterclass

Participants are expected to meet these conditions when accepting their place in the Masterclass.

- Complete the required pre-reading.
- Complete the Learning agreement / REDCap survey. The agreement requires all participants to complete three evaluation tasks (pre-Masterclass, post-Masterclass and 6 months post-Masterclass). Each task will take less than 20 minutes to complete. The learning agreement will enable SHP to publish evaluation outcomes about the Masterclass.
- Participants will be asked to give a presentation back at their workplace after they have completed the Masterclass.



• Participants will agree to be contacted by SHP to promote the outcomes of the Masterclass across the SHP Community.

Cost of the Masterclass:

- There is **no cost** for participants.
- Participants are responsible for arranging and paying for their own travel to the Masterclass venue in Sydney.
- SHP **is not** able to provide funding to cover locum replacement for clinical days or to reimburse applicants for leave from their substantive role.

Morning tea, lunch and afternoon tea will be provided on both days.

5. EOI Process

Applicants must submit the following documents electronically. The EOI due date for each Masterclass consists of

- Clinical Master Class Close of Business 15th of March
- AISN Master Class Close of Business 19th of July

The EOI is to be submitted to <u>shp.implementationscience@sydney.edu.au</u> NB: Late applications will not be accepted or requests for extensions after the due date.

EOI Form

The EOI forms that are required to be submitted must include:

- EOI form
- **Three-page concept outline** describing your plan: Please use the headings outlined in the EOI form.
 - Headings 1-11 should be used as a guide and you do not need to include information under every heading, only the sections that are relevant.

File Format: Please submit your application as one PDF document.

Review Process: All EOI's will be reviewed by a panel with expertise in Implementation Science. The panel will use the selection criteria and strive to select applicants with a range of experience.

Wait Listing: Unsuccessful Applicants that meet the Eligibility Criteria may be placed on a wait list in the case that a place becomes available.
